After a full run through of "This Is Me" some of Priestley's young performers sang solos before receiving critiques from Natalie and her travelling companion Andrew Hodge, who has himself toured across America in shows such as "Cats", "42nd Street" and "A Chorus Line".

Several of the college's former students returned for the workshop with Hannah Gallimore wowing the American Idol semi-finalist.

"I had the best time working with the students at Priestley College," said Natalie. "The enthusiastic energy and natural talent in that room was so inspiring. I hope to come back and work with them in the near future!"

Manufacturers grew at their slowest pace as export demand weakened and order books eased.

Factories have grown in every month for almost two years and the purchasing managers index (PMI) indicates output increased again in April.

Its score of 53.9 indicates moderate growth – any score above 50 indicates an expansion but this is the slowest pace in 127 months.

Blue Whale Media climb Snowdon for Warrington Animal Welfare

THE Blue Whale Media team recently climbed Wales' highest peak, Mount Snowdon, and raised over \pounds 1000 pounds for Warrington Animal Welfare.

A charity dedicated to safeguarding animals, this animal shelter provides a warm home for a variety of abandoned animals including dogs, cats, rabbits, guinea pigs and more. Kept running entirely by donations, Warrington Animal Welfare receives no government funding and relies on a devoted team of over 70 volunteers with only a small amount of part-time staff.

The team of hikers managed to raise over $\pounds500$ for the charity through public donations, with Blue Whale Media matching the publicly raised amount to make for a total sum of over £1000 raised for the animal shelter. The ascent began at 9 AM in the morning from the base of the mountain inside Snowdonia National Park with the group tackling the nine-mile Llanberis path to the top of the mountain. While the Blue Whale Media hikers slightly underestimated the warm weather on the day, there were plenty of breaks in between the hike in order to rest and try out the team's Blue Whale Parrot drone. With plenty of open air to operate, the team captured some fantastic images of the mountain and the surrounding scenery. By half five, the team had conquered the summit of the mount were back at the start of the trail in the mountain's pub for a cold beer.

While the team is already planning

another fundraising event in the form of a 5K fancy dress charity fun run, everyone at Blue Whale Media was ecstatic with the sum raised for Warrington Animal Welfare. Based at Slutchers Lane in Warrington, the animal shelter takes in unwanted, abandoned and abused animals and work tirelessly to save and improve the quality of life for hundreds of animals and pets. The Warrington Animal Welfare team pride themselves on never putting a healthy animal down and always accepting adoptions back in case their new home isn't the right fit. Along with all this, they provide low-cost neutering services for cats and kittens, as well as a free neutering scheme for low-income households.

Consultation launched on transport plan to boost Cheshire and Warrington economy

BUSINESSES and residents across Cheshire and Warrington are being urged to have their say on a new transport strategy for the region designed to boost economic growth over the next 20 years.

For the next 12 weeks Cheshire and Warrington Local Enterprise Partnership (LEP) is consulting on its draft Transport Strategy setting out how transport provision within the region should develop to help create a £50bn a year economy by 2040.

Working with Cheshire East, Cheshire West and Chester and Warrington councils, the LEP has identified the strategic transport priorities that will be essential for achieving Cheshire and Warrington's growth plan.

Cheshire and Warrington is already well connected, sitting at the heart of the strategic road network and is well placed in relation to the strategic rail network. A number of key rail hubs, including Chester, Warrington and Crewe provide access to the West Coast Mainline linking the sub region with services to London and Scotland. The region also benefits from proximity to

a number of key international gateways including Manchester and Liverpool Airports and the Port of Liverpool.

However, connectivity varies within the sub region, with lower levels of accessibility in some rural and intermediate areas, while it

suffers from significant peak period congestion on the highway network and infrequent and slow local rail services.



Student secures gold in Olympiad

A Warrington student struck gold in a challenge that tested his application of chemistry.

Matthew Turton, who studies A-Level Chemistry, Physics and Maths at Priestley College, finished in the top 8% in the country in the annual UK Chemistry Olympiad.

"We were tested on the knowledge we've learnt in college, but also what we have picked up outside of class," said Matthew.

"I knew some Physics that came up in the paper and that really helped."

The two-hour paper – taken at Priestley College – covered topics as diverse as nuclear decay and the shapes of molecules.

From Priestley, 15 chemistry students took up the challenge and all received a certificate for taking part.

Matthew, a former pupil at Bridgewater High School, plans to study Materials Science and Engineering at Sheffield University after completing his A-Levels.

He said: "The Olympiad was a challenge, but it also gives you something to put on your personal statement that will help make you stand out."

Priestley Tutor Wendy Winnard congratulated all the students who participated and said it was great preparation for the forthcoming A-Level exams.

"Universities and employers are looking for that extra something from our young people so this kind of experience goes a long way," she said.

"Students took the paper in their own time and built up extra knowledge outside the classroom in order to give themselves the best possible chance of success."



All set for Disability Awareness Day 2018

WORK is well underway for the 27th annual Disability Awareness Day which takes pace at Walton Gardens, Warrington, on Sunday, July 15.

Founder and event co-ordinator Dave Thompson, now Chief Executive of Warrington Disability Partnership, said: "In 1992, who would have thought that a disability information event organised by a very small, then unknown disability group, would grow in size and stature, and would influence the development of a now internationally-recognised Disability Awareness Day.

"This year sees the '27th Anniversary event', which has inspired people from all over the world and provided advice and support to 100,000's of disabled people, their families, friends and carers <" added Dave, who helped co-found Warrington Disability Partnership after breaking his neck in a sporting injury.

More than 25,000 visitors are expected to attend this year's DAD, the world's largest not-forprofit, voluntary-led, pan-disability exhibition, which will once again be hosted at Walton Hall Gardens on Sunday, July 15 with the support of joint principal sponsors St George Healthcare Group and St Mark Universal Copts Care.

A huge tented village housing approximately 250 exhibitors – including equipment suppliers; transport; holidays; leisure and employment providers; and support groups and services – is set to attract visitors to travel from all over the UK and beyond.

Inclusive Arts is just one of the highlights of the event – with a number of disabled artists including nationally recognised performers such as the Ella Performance Group and Carly Ryan. The Main Arena will offer visitors a range of family entertainment including guide dog display teams, falconry displays and a number of marching bands. Also on-site will be the fully accessible Sports Zone with have-ago events including Scuba Diving in the temporary pool, climbing wall, shooting, archery, basketball and much more.

A free, accessible Park and Ride service is available from Wilderspool Park; plus a free bus service every 30 minutes starting at 9.30am from Warrington Bus Interchange; British Sign Language (BSL) interpreters; trained assistants; and a scooter / wheelchair loans service promises to ensure DAD is fully inclusive to all.

"The background story to DAD is a great example of just how far a 'can do' attitude can take you," says Event Founder and Co-ordinator, Dave Thompson MBE DL.

"What started out as a one-off event is now one the highlights of the international disabled community's calendar – inspiring similar events as far afield as India, Cameroon, Uganda, Gibraltar and Thailand. Our team is also working closely with one of our sponsors St Mark Universal Copts Care teams based in the UK and working in Egypt and Sudan."

The big day on Sunday July 15 from 10am to 5pm – will be a fitting finale to a week comprising a variety of complementary events to savour, which are guaranteed to attract many more visitors to events aimed at disabled children and young people, mental health, learning disability, carers and a cultural diversity evening.

ARUGBY player secured his first England cap after competing in the nation's win against Ireland.

Harry Wilkinson, a student a Priestley College, regularly plays for Chester, but was called up for the England County U18s team in April.

"I missed out on selection originally so I was really pleased to be asked to play," he said.

"It means a lot to play for my country so it was amazing to be standing their singing the national anthem."

Harry, who studies BTEC Level 3 Sport at Priestley, trained for two days with the squad in Portsmouth ahead of the second test match.

"I plan to take a year out after college to work and then possibly go to university to study strength and conditioning."
